

READ THIS FIRST

Manatee Cove Golf Course (MCGC) is a Department of Defense (DOD) golf course located on a military instillation that allows restricted access for civilian golfers **to the Golf Course ONLY**.
Base access is a privilege and may be revoked or denied.

Always be courteous to our Men & Women in uniform & Security personnel. <u>Inappropriate</u> <u>behavior is grounds for denial.</u>

All requests must follow the procedures below. All personal information will be kept confidential and protected under the terms of the Privacy Act. Incomplete or illegible applications will not be processed.

- Applications are processed by the golf course and sent to security every Tuesday. Due to the volume of applications, we do not contact customers directly.
- Applications may be sent in by fax, mail or hand delivered by those with access. We do <u>not</u> accept applications through email.
- <u>1 week</u> after submitting to the GOLF COURSE you may contact the Pro Shop at 321-494-7856 to confirm your application was received and sent to security.
- <u>1 week after the Golf Course submits your application to Security, you may call Security at</u> (321)494-0427 or (321)494-2658 to schedule an appointment.
- Negative findings on background checks will result in a denial of access.
- If you are approved for access to Patrick Air Force Base, Security will conduct an interview where conditions and restrictions of base access are reviewed, and the applicant is asked to sign a form indicating agreement to the terms and conditions of access. Please bring *Legal Picture ID* (Driver's License, State ID or Passport).

Once you have your pass you are *authorized to use the South Gate ONLY* (from South Patrick Dr.). You *MUST* show your pass to the guard at the gate. *Any passengers with you MUST have their own pass*. After being cleared through the gate, turn left immediately onto Marina Rd and continue to the Golf Course for use of the facility. When use of the facility is completed, you must use the same route to directly exit the base. *Any deviation from this route may result in the loss of base entry privileges.* Civilians are not authorized to use the Marina facilities unless directed for special occasions. All personnel and their property are subject to search while gaining access to or on Patrick SFB. Seat belts must be worn at all times while on base. Talking and texting on a cellular phone while operating a motor vehicle is prohibited. Always stop for pedestrians. Always have your access badge on your person and be prepared to present it when asked.

All personnel must follow Space Force and Golf Course policies while on base. Please see the Pro Shop for information on policies, rates and tee time procedures. We are sorry, but Foreign Nationals are not permitted access at this time.
